

Minutes of the Regular Town Council Meeting Monday, Nov 13, 2017

1. Call Meeting to Order

The meeting was called to order at 7:00 pm by Mayor Harry Ward. Council members in attendance were Ken Lewis, Kathy Lock Bob Wood and Becky Craft. Community members in attendance are shown on the attached sign-in sheet. Harry acknowledged and thanked everyone for their support.

2. Approval of the Nov 13, 2017 meeting agenda

Motion: A motion was made by Ken Lewis to approve the Nov 13, 2017, meeting agenda. The motion was seconded by Becky Craft. **The motion carried** *unanimously,* **5** – **0**.

3. Approval of the Oct 9, 2017 Town meeting minutes

Comcast – Channel Changes

Jimmy Dalton reported that he is in the process of getting some snow removal quotes.

He will contact Jerrys Paving to inspect and quote on paving that needs to be done on town streets and access roads.

Jimmy also noted that he is in the process of getting new street lights where needed.

The Restrooms should be closed later this week.
